Lindy Willmott is a Professor of Law at QUT and researches and publishes extensively on the law at the end of life. Lindy co-leads projects to provide legal training to medical specialists about end of life law, and an accredited training program for doctors involved in assisted dying in Victoria. Lindy is a Board Member of Palliative Care Australia. She has also served on the Queensland Law Reform Commission and the Queensland Civil and Administrative Tribunal. Lindy will review assisted dying legislation internationally and across Australia, highlighting specific provisions of the Victorian law.
