Hon. John Byrne AO RFD

The Hon. John Byrne AO RFD recently retired as Senior Judge Administrator, Supreme Court of Queensland, after serving 28 years on the Bench. A graduate in Arts and Law from The University of Queensland, he attained his Master of Laws from The University of Michigan, before his call to the bar in 1974 and subsequent appointment as Queens Counsel in 1982. In 2013, he was appointed Officer of the Order of Australia for distinguished service to the judiciary and to the law as a leading contributor to legal education and reform, and to professional development and training.

Justice Byrne presided over many civil and criminal trials, including the Baden-Clay prosecution. Drawing on his many years' experience, his address will focus on how medical practitioners whose evidence is adduced in court, may better structure and express their expert evidence to render it clearly understood; and how lawyers may better instruct experts to yield this outcome in both the civil and criminal spheres.
