**Guest Speaker: Dr James Morton AM,
Clinical Haematologist, ICON Cancer Centre**

In 2015, Dr James Morton AM was recognised in the Australia Day Honours for his “significant service to children with Autism Spectrum Disorders through not-for-profit organisations, and to medicine in the field of oncology.” In 2004, James and his wife Louise established the AEIOU Foundation which provides specialised early childhood programs for children with Autism, as a result of their own personal experience of having a 2 year old child diagnosed with this condition. James is now Patron of the AEIOU Foundation.

James was a Board Member of the Leukaemia Foundation of Queensland from 2000-2008, and conceived and initiated the World’s Greatest Shave for a Cure. For more than two decades, this event has raised over \$300 million in support of Leukaemia.

James attained his MBBS from The University of Queensland in 1987 and was awarded a University Gold Medal for his outstanding academic results. He completed specialist training in clinical haematology and stem cell transplantation at the Royal Brisbane and Mater Hospitals. In 1996, James was the International Fellow at the prestigious Fred Hutchinson Cancer Centre, Seattle. Returning to Brisbane, he joined Haematology & Oncology Clinics of Australasia, now Icon Cancer Centre, practising as a clinical haematologist. James is also a senior specialist, Leukaemia and Bone Marrow Transplant Service, RBWH.

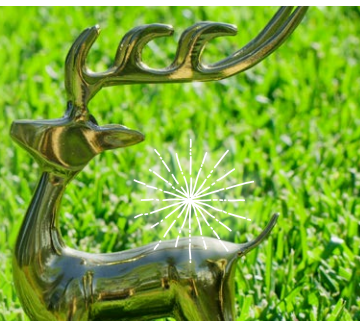
