**Alastair Blanshard** is the Paul Eliadis Professor of Classics and Ancient History at The University of Queensland. Alastair completed his doctorate in Greek History at Cambridge before going on to teach at Oxford, University of Reading, and Sydney University. He has held fellowships at Harvard's Centre for Hellenic Studies, Corpus Christi College, Cambridge, and the University of Cincinnati. He works on Greek history and the impact that the Classical world has had on the modern. He has written books and articles on topics including the Roman orgy, Greek statuary and the popularity of abdominal muscles, and representations of Greece and Rome in cinema. He regularly appears on radio and in the print media. His latest book is *The Classical World: All that Matters*.
